

## Regulation Jan van Dijk Victimology and Victims' Rights Award Master thesis award

### The Award

1. The Jan van Dijk Victimology and Victims' Rights Award will be awarded in two categories: the best master thesis and the best dissertation in victimology and victims' rights. The award is an initiative of Fonds Slachtofferhulp.
2. The prize consists of €1.750,- granted to the author of the best master thesis. The award ceremony will take place on **February 27<sup>th</sup>, 2024**. Information about the time and location will follow.
3. In this regulation, published on [www.janvandijkaward.nl](http://www.janvandijkaward.nl), you can find information regarding the requirements for participation, the submission procedure, the assessment procedure, the rights of the participants and other information regarding participation.

### Requirements for participation

4. Participation is open to all former and current students of a master of a university level academic education at a Dutch or Belgian University.
5. To be considered eligible, the master thesis must meet the following requirements:
  - a) Meet the requirements set for a master thesis at the Dutch or Belgian university where the master thesis was graded;
  - b) a minimum of 10 ECTS was awarded;
  - c) must have received at least an 8.0 as a final grade according to the Dutch grading system;
  - d) Written in either Dutch or English;
  - e) Relevant to the legal status of, or the assistance (legal, social, psychological) to, victims of crime, accidents and disasters.
  - f) Was assessed and graded in the period between October 2021 and October 2023.

### Submission Procedure

6. The author or the first supervisor of the master's thesis submits the documents to the organization of the Jan van Dijk Victimology and Victims' Rights Award by sending them to [info@janvandijkaward.nl](mailto:info@janvandijkaward.nl). Only submissions that are sent before **November 19<sup>th</sup>, 2023** qualify for the Jan van Dijk Victimology and Victims' Rights award 2024. Any possible changes regarding the submission period or award ceremony will be communicated through the website [www.janvandijkaward.nl](http://www.janvandijkaward.nl).
7. The following information must be submitted:
  - a. Master thesis in PDF with:
    - Contact information of the author;
    - Contact details of the first assessor;
    - The educational institution;
    - The study in which the Master's thesis was assessed;
    - The obtained grade.
  - b. Summary (max. 1,000 words) in a separate PDF document with:
    - Name author;
    - Title thesis;
    - Name first assessor;

- Final grade;
- Research questions;
- Key findings;
- Conclusion and Recommendations.

c. The digital version of the master thesis is accompanied by an official document proving that the thesis was marked with at least an 8.0.

### Assessment Procedure

8. The master theses will be assessed by a jury. Who is part of the jury will be announced at a later stage.
9. The first selection is based on the submitted summary.
10. The jury will assess the master theses on the basis of the following criteria:
  - a. Originality;
  - b. Contribution to the state of the art about the legal status of – or the assistance (legal, social, psychological) to victims of crime, accidents and disasters;
  - c. Scientific quality.
11. In the event of a close relationship between a participant and a jury member, the relevant jury member will refrain from assessing and voting on this specific participant.
12. The jury will communicate, through the organization, a few weeks before the ceremony which three master theses will be nominated for the award.
13. The winner of the master thesis award will be announced during a special award ceremony.
14. The nominated participants are expected to attend the award ceremony and give a short presentation of their master thesis. Presence and nomination are –barring force majeure– a condition for winning the prize. Further guidelines on this will be communicated upon nomination.

### Rights of the participants

15. The copyrights of the submitted theses will remain with the authors. The nominees will provide a summary of their master thesis in popular-science style. The nominees will produce an accessible Dutch summary of their dissertation a few weeks before the award ceremony. In addition, they grant the organization of the Jan van Dijk Victimology and Victims' Rights Award permission to publish this text (including on the internet) with acknowledgment of the source. Further agreements will be made with the nominees at the time of compiling the publication. 16. Participants are expected to have taken notice of this regulation and to accept the terms and conditions as prescribed by this regulation.
